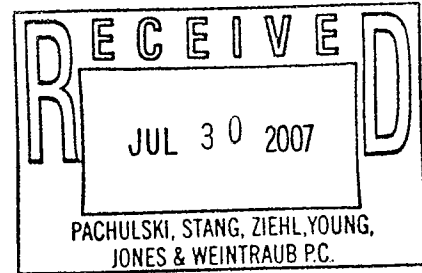

21 **PLEASE TAKE NOTICE** the Court has fixed a Claims Bar Date of **September 14,**  
22 **2007**, in this Chapter 9 case pursuant to Federal Rule of Bankruptcy Procedure 3003(c)(3).  
23 Further, the order of the Court provides that a Claim will not be allowed if filed after the Claims  
24 Bar Date of **September 14, 2007**, except as otherwise permitted under the Federal Rules of  
25 Bankruptcy Procedure or by the Bankruptcy Court.

26 **PLEASE TAKE FURTHER NOTICE:** All creditors (except governmental units) who  
27 have **not** previously filed a claim with the Bankruptcy Court must file a Proof of Claim with the  
28 Court on or before the Claims Bar Date. This notice applies to all creditors, vendors, employees  
or former employees of the Debtor. The Claims Bar Date applies to any and all claims you may  
hold against the Palm Drive Health Care District, d/b/a Palm Drive Hospital, whether or not such  
claim is liquidated, unliquidated, fixed, contingent, matured or unmatured.

The Debtor filed its *List of Creditors* under 11 U.S.C. § 924 on July 11, 2007. The  
Debtor, however, has listed the claims of all creditors as disputed, contingent or unliquidated.

18 UPON THE APPLICATION of the debtor, Palm Drive Health Care District, ("District")  
19 the debtor, the agreement Unsecured Creditors Committee, by counsel, and Good Cause Appearing,

20 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Proposed Notice

21 1. That the Proposed Notice, attached as Exhibit A to the Application is approved;

22 2. The Notice shall be mailed on or before July 31, 2007, the Claims Bar Date for non-  
23 governmental creditors is set as September 14, 2007, if mailing is delayed, the claims bar date shall  
24 be extended by the number of days the actual mailing date is after July 31, 2007. The Claims bar  
25 date for governmental entities is 180 day after the filing of the Petition and is set as October 3, 2007.

26 3. And Further, The Notice shall be published once in the Santa Rosa Press Democrat and  
27 Sonoma West Times.

28 4. The Claims Bar Notice shall require all creditors to file claims, notwithstanding 11  
U.S.C. §925 and Rule 3003. The Notice shall include a Proof of Claim Form with the case name

and number on the form.

5. The Notice shall include the following:

WARNING: IF YOU FAIL TO TIMELY FILE A PROOF OF CLAIM BY SEPTEMBER 14, 2007, YOU WILL BE FOREVER BARRED FROM PARTICIPATING IN THIS CHAPTER 9 CASE, FROM VOTING ON ANY PLAN OF ADJUSTMENT FILED IN THIS CASE, AND FROM RECEIVING A DISTRIBUTION UNDER ANY PLAN OF ADJUSTMENT. YOU WILL, HOWEVER, BE BOUND BY THE TERMS OF ANY PLAN OF ADJUSTMENT CONFIRMED BY AN ORDER OF THE COURT.
